To God be all the Honor and all the Glory!



The UniEVANGÉLICA

On March, 2004, this institution was called Centro Universitário de Anápolis (UniEVANGÉLICA). It was accredited as a college center, and it became the first College in Goiás. Until then, it was denominated Faculdades Integradas da Associação Educativa Evangélica, as a result of the unification of Faculdades Isoladas(Isolated Coleges) of AEE. Since1993, this institution no longer exists.

With an eye on the present and the vision turned to the future, this institution acts strategically in order to conduct an innovative and shared management. Therefore, it reviews priorities to enable its mission participating effectively in the process of the socioeconomic and cultural framing of the region in its range. UniEVANGÉLICA is considered a reference at the regional scenario, both for the quality of education and the strategic geographic positioning. A location that attracts students from neighboring cities such as: Goiânia, Goianésia, Jaraguá, Pirenópolis, Alexânia, Nerópolis, Vianópolis, Silvânia, Ceres and Abadiânia.

UniEVANGÉLICA develops its academic activities towards the achievement of its objectives: education, research and expansion, consolidating the mission to prepare professionals for an innovative and competitive labor market. This mission is achieved by continuously updating the Institutional Pedagogical Project.

History

Associação Educativa Evangélica(AEE) was founded on March 31, 1947, by Antônio de Oliveira Brasil, Archibald Tipple, Arthur Wesley Archibald, Dayse Fanstone, Newton Wiederhecker, Nicola Aversari, Severino Araújo e William Benister Forsyth. All previously mentioned were evangelical leaders and missionaries under the leadership of Reverend Arthur Wesley Archibald. The foundation of the institution aimed at education and training of children and young adults in the region of Goiás.

AEE has been founded in order to establish and maintain urban and rural schools at all levels. AEE is a confessional institution, frankly evangelical Christian. This is an interdenominational institution that has the Sacred Scriptures as the sole rule of faith and practice. Another contribution of AEE is the foundation of schools in several communities across Goiás state.

Some of the elementary schools founded by AEE are: Colégio Couto Magalhães, in Anápolis, Colégio Álvaro de Melo, in Ceres, Educandário Nilza Risso, Escola Luiz Fernandes Braga Júnior, Normal Regional and Sítio de Orientação Agrícola, in Cristianópolis (the last ones were closed in the course of the time).

AEE has also founded four separated colleges: Faculdade de Filosofia Bernardo Sayão in 1961, Faculdade de Direito de Anápolis in 1969, Faculdade de Odontologia João Prudente in 1971 and Faculdade de Filosofia do Vale de São Patrício, at Ceres/GO, in 1976. In 1993, all these colleges became



Faculdades Integradas da Associação Educativa Evangélica under an Unified Regiment.

On March 15, 2004, the Faculdades Integradas da Associação Educativa Evangélica, motivated by the conviction of the relevance of its educational proposal based on Christian, ethical and democratic values, are accredited as Centro Universitário de Anápolis (Anápolis University Center) by Ministerial Decree No 628 of March 15th, 2004, published in D.O.U. No 52 of March 16th, 2004.

AEE is always expanding the scope of its mission. In 2005, it acquired a college named Sociedade de Ensino Raízes, known today as Faculdade Raízes. In 2007, AEE also acquired another college named Faculdade Betel de Goianésia(FABEGO), now renamed as Faculdade Evangélica de Goianésia (FACEG).

MISSION STATEMENT, VISION, PRINCIPLES AND VALUES

This institution, founded on its Christian principles, promotes, with excellence, the knowledge through different levels of education, research and extension. This institution pursues the formation of citizens committed to sustainable development.

The Institution also envisions that, it will be recognized as a Christian institution of education and a center of excellence in teaching, research and extension, using innovative concepts of management.

Through the effectiveness of its mission, this institution emphasizes values such as competence, professionalism, participatory work that should be guided by ethical, moral and Christian principles.

Chaplaincy

AEE Commitment to Life

Associação Educativa Evangélica (AEE) is a result of the missionary dinamic of the Christian churches. The chaplaincy ministry is an extension of their mission (Mark 16:15). The Chaplaincy aims at the critical consciousness of the institution in all aspects, exerting its prophetical and sacerdotal role.

The concept of pastoral ministry is wide ranging as it relates to care and spiritual orientation to people, and it becomes even wider when it includes chaplaincy.

However, evangelism reaches other areas of the educational, administrative and relational process, promoting Christian testimony and the exercise of critical consciousness in all the aspects of the institution, highlighting its confessional nature.

ACTIVITIES

The Chaplaincy role goes beyond isolated activities. It elaborates ongoing plans, projects and programs in partnership with other segments of the Institution in order to accomplish its mission in full. The chaplaincy accomplishes that through the following activities: Pastoral counseling, Devotionals, Bible Study Groups, Institutional projects and Events.

The chaplain job is:

- to participate in social projects of the Institution;
- to promote community camps for the students from both institutions: Colégios Couto magalhães(Anápolis) and Colégio Álvaro Mello(Ceres);
- to host Marriage enrichment meetings;
- to coordinate AEE community choir.
- to make part of the Comissão Interna de Prevenção de Acidentes(CIPA), there is, a committee for accident prevention.

Criar e Tocar Project

Social inclusion through art

This project was created to promote social insertion of children and adolescents (from 9 to 17 years old) through music and visual arts. The partnership between UniEVANGÉLICA and City Hall/ City Cultural Department is responsible for the effectiveness of the social action programs held by the institution.

The candidate for this project (2005) must be interviewed and he/she also must meet the selection criteria, that is, belonging to a low-income family.

Creating and Playing is a relevant project because it propitiates an artistic and professional training to the participants and also it plays an important social role.

In 2010, the project had an enrollment of 214 participants. About 183 students have benefited from lessons of art and orchestral instruments (brass, wind, string and percussion instruments). In addition to the artistic learning, the project also offers tutoring, quality food and scholarship to the participant thanks to the partnership with Programa de Erradicação do Trabalho Infantil (Peti), a partnership action that involves federal and municipal governments.

Employee choir of the Associação Educativa Evangélica

The primary purposes of the Employees Choir of AEE are:

- to develop the performance of the choral music with the Institution staff;
- to offer greater value of music opportunities to participants that will foster further appreciation for new musical techniques;
- to enable the enhancement of musical capabilities at all levels.

UniVIDA Program

UniVIDA program has been designed by AEE to promote the complete development of the students, preparing them intellectually, morally and spiritual and socially as well. The program invests in study, research and extension of one of the most important public health issues today, the misuse of drugs.


The program aims to promote life quality that is a tool for healthy living.

UniVIDA works in partnership with Gente Livre(Free People) – a Center for Prevention of the Misuse of Drugs in Goiânia. UniVIDA promotes drug abuse prevention actions on an ongoing basis with the faculty, students, staff and community. It also offers a support program for the participants through monitoring, personal counseling, Clube de Discussão sobre Drogas-CDD(Brainstorming Meetings about Drugs), lectures, debates, courses, seminars, home visits and cultural events. UniVIDA is recognized by Conselho Estadual de Entorpecentes/CONEN/GO(State Board of Narcotics), registered under number 205333128/02.

Academic Dean's Office

ACADEMIC DEAN'S OFFICE (PROACAD) is an advisory body of the UniEVANGÉLICA Rectory. It sets the value of graduation within the Institution, through continuous improvement of teaching methods. To achieve this objective, PROACAD makes proposals and implementation of policies that contribute to that improvement, according to the Plano Nacional de Educação (National Educational Plan), and also according to the Plano de Desenvolvimento Institucional-PDI(Institutional Development Plan), and following the Projeto Pedagógico Institucional-PPI (Institutional Educational Project) and other legal and institutional actions.

PROACAD is responsible for planning, coordination, execution, supervision and evaluation of the teaching and learning activities in undergraduate courses (Licentiate, Bachelor and Professional Degrees) and the following degrees by improving the scope of its activities. ACADEMIC DEAN'S OFFICE is also responsible for the selection, performance monitoring and qualification of undergraduate courses through a selection process, placement and assistance to UniEVANGÉLICA students.

PROACAD is assisted by the Graduation Chamber, a collegiate body composed by the overseers of the Superior Institutions, Course Directors and Representatives of Sectors. This Graduation Chamber aims to define, evaluate and propose improvements in education policy and in management of UniEVANGÉLICA units/campus.

Support departments for Academic Dean's Office

Department of Pedagogical Support

It is responsible for the teaching-learning process. Its activities include elaboration of educational institutional guidelines and support for the development and evaluation of the graduation activities aiming the better quality of education. The Department of Pedagogical Support is organized into three coordinating areas:

Faculty Support Department

This department takes care of the teacher's selective process. It is also in charge of the reception and integration of the new faculty member. Besides that, Faculty Support Department follows and implements the institutional placement program and the training program for the faculty.

Assessment and Teaching Qualification Department

This Department works closely with the Assessment Committee (CPA) and it gives support to other departments as well. Its goal is to verify all the situations involving the teaching, learning and management activities reinforcing their potential aspects and warning about the probable weaknesses to be overcome.

Educational Planning Department

This department is responsible for designing all the Educational Projects (PPCs) of the new courses to be implemented. It also supports the revision and updating of courses already in progress. Besides that, it supervises and helps the educational boards and their educational coordination in the process of curricular alterations, in order to improve the courses quality.

Institutional Placement Program

This program aims to promote the faculty and students academic growth. It seeks to emphasize Portuguese Language as an important means of communication, interaction and also social advancement. As a result, the native language will be properly valued inside and outside the university environment.

UniLINGUAGEM – Portuguese Language Workshops

Every Saturday (Mornings and afternoons), UniLINGUAGEM offers workshops on Portuguese Language open to all IES students. The workshops address the different aspects of the Portuguese language in practical situations. The program has become more and more effective each year benefiting our faculty, courses directors, undergraduates and also teachers of municipal and

state education.

Student Support Department – UniATENDER

It is the institutional care service that interfaces between UniEVANGÉLICA sectors and courses to enable integrated actions to support the student. UniATENDER aims to welcome, integrate, serve and chaperon the students individually and collectively, addressing their needs and providing a better human and professional development. In brief, UniATENDER works for developing ethical and Christian values on their students, as well as healthy living and social responsibility.

Student Support Department is based on an institutional student support policy and it seeks to meet the guidelines and requirements of the Board of Education regarding the student service and monitoring. It also promotes actions coming from the priorities established by the Institution's Strategic Plan.

Distance Education Department – UniVIRTU@L

This department is responsible for the implementation and monitoring of classes in distance education and also supervises the ongoing classes for undergraduate, graduate and extension. Distance Education Department manages the university web portal (UniVIRTU@L), and it provides technical and pedagogical support to faculty and students of the Institution.

Medical Waste Management Program (PGRSS)

PGRSS aims to point and describe the actions relating to solid waste management. It observes the waste characteristics and possible risks in UniEVANGÉLICA. It is also part of its job to closely monitor the generation, segregation, storage, collection, transport, final processing and disposal of the waste for health and environment protection. Pro Dean's Office for Post Graduation, Research, Extension and Community Action (ProPPE)

Pro Dean's Office for Post Graduation, Research, Extension and Community Action was founded in 2004. It is responsible for elaborating and implementing policies to develop post graduate education, research and extension activities in such a way to promote integration between post graduate courses, as well as a link to the undergraduate education.

The Pro Dean's Office (ProPPE) has to be acquainted with the institutional community in order to understand the socio economic and political reality in their field of action. Through this understanding, pro dean will be able to act in an effective way and change the situation, promoting the interface of teaching, research and extension.



Pro Dean's Office for Post Graduation Studies, Research, Extension and Community Action Support Departments

Post Graduation Department Latu Sensu

UniEVANGÉLICA offers post graduation courses in different areas aiming the strengthening of organizations through the development of professional expertise in its students, since the projects are developed according to the market needs. These projects are offered to the community by the institution alone or through partnerships with other companies.

Post Graduation Latu Sensu offers 42 courses in our facility with 1.217 students enrolled, and 19 off-campus courses with a number of 472 students, with a total of 61 courses and 1.689 students.

Post Graduation Department Strictu Sensu

UniEVANGÉLICA has created post graduation Stricto Senso in order to attract countryside human resources and to incorporate qualified teachers in the institution. From the creation of ProPPE, working groups were designed to structure the Master Degree courses.

From this effort, the first Masters Degree courses were implemented in 2005. In partnership with UEG and SCU the following courses were created: Professional Master in Management, Research and Development in Pharmaceutical Technology. And, in 2006, more Courses such as: Multidisciplinary Master in Society, Technology and Environment. Besides that, two other inter-institutional Master Courses - Education(UCG) and Law (UniCEUB) - were created improving the rate of qualified teachers in the region.

The institution has encouraged and sponsored scholarships for Masters and PhDs.

Research Department

Research is seen as an ongoing process, in permanent construction. That happens because it analyses and interprets social and natural phenomena, which requires constant methodological innovations. These innovations occur because the relationships in society tend to change very quickly.

Researching process relates to the scientific community in two distinct ways:

The first way has to do with the self-training process of the teacher, since researching is the act of recycling, rethinking concepts, inquiring with the purpose of publishing the results, analyzing and seeking explanations for the studied phenomena. The research results may bring answers to specific daily life problems.

Secondly, the researching process makes teachers and researchers available to our students. They will guide those future teachers and researchers in their first steps toward logical understanding of Science, creating the habit of inquiring and relating the researching process with the community.

During 2010, PIBIC-CNPQ Program funded 6 projects with 7 coordinator teachers, 4 faculty researchers, 8 scholarship students and 8 volunteer students. PBIC-FUNADESP developed 43 projects with 41 coordinator teachers, 25 faculty researchers, 79 scholarship students and 37 volunteer students.

Department for Support of Research and Technological Innovation (NUPTEC)

It is an institutional mechanism capable of strengthening the bonds of their researchers with civil society, businesses and public agencies, by focusing on fundraising and looking for ways to foster innovation and technology transfer.

UniINCUBADORA

This is a not-for-profit program linked to Pro Dean's Office of Postgraduate Studies, Research, Extension and Community Action through the Department for Support of Research and Technological Innovation (NUPTEC) of UniEVANGÉLICA whose responsibility is to transfer technology, providing specialized services. It also must promote interaction between the University Center and entrepreneurs as well as the society at large. This achievement is possible thanks to partnerships as: Anápolis City Council, Rede Goiana de Inovação, SEBRAE, Finep, FUNTEC, CNPq, SECTEC, ACIA and others.

The main beneficiaries of UniINCUBADORA are incubator Companies such as: UpperTec, M3D Design, Seta Publicações and EcoTire.

Research Ethics committee (CEP)

CEPs are multidisciplinary collegiate boards that are independent of the institutions that conduct research involving human beings. They are created to defend the interests of research subjects in their integrity and dignity and also to contribute to the development of ethical research standards. The UniEVANGÉLICA Research Ethics Committee started its activities in 2006.

In 2010, CEP received 168 project research protocols, and held a total of 505 attendances.

Extension Department

It is a key factor in the construction of pedagogical action in higher education for the formation of citizenship and ethical moral and Christian values. Higher Education plays a relevant role in building a more inclusive and better world. This is possible when the value of science and the professional practice of acquired knowledge work as the foundation of the critical thinking, of the consciousness and social transformation.

Extension, like the other functions of higher education, is committed to social responsibility based on a set of values, assumed and practiced with the purpose of integrating the triad: teaching, research and extension.

The social responsibility of UniEVANGÉLICA is relevant in the sense of spreading the practice of actions in order to promote the common good. It also seeks to meet the diverse social demands especially the training of technical and scientific skills. Above all, the institution addresses those demands related to the formation of values, such as leadership, solidarity, cooperation, volunteerism and entrepreneurship.

UniEVANGÉLICA is committed not only to maintain and implement what is already carried out by Extension and Social Action, but also it is continually openned to deploy new shares, aiming to stimulate and develop social responsibility to benefit not only its own community but its surrounding areas as well

In UniEVANGÉLICA, extension activities are conducted in conjunction with the institution courses (undergraduate, technology experts, and post graduate) and its departments, through courses, events and projects.

Extension Course Department

UniEVANGÉLICA extension courses are developed in four areas:

- Free courses: they cover the urgent needs of the market work within a vision of upgrading and qualification.
- Special subject courses: They attend the graduate student who had failed to attend a discipline required in the curriculum.
- Language Center: it offers second language courses in order to expose the learner to linguistic and cultural varieties.
- Public Service Exams: They provide basic and specific subjects of public service exams at national, regional and municipal levels.

Service Delivery to the Community

SCHOOL/CLINIC OF PHYSICAL THERAPY - UniFISIO

School/Clinic Physical Therapy treats patients with orthopedic, traumatologic and rheumatic problems. It also treats women with dermatological and esthetic problems. UniFISIO assists adults and children suffering from neurological, cardio respiratory diseases. Patients are referred by municipal CAIS handing the clinical diagnosis and also a SUS (Federal Health Plan) request form for physical therapy.

Objective:

UniFISIO aims to provide social, professional and cultural learning activities exposing the student to real life situations.

EDUCATIONAL DENTAL CLINIC (COE)

Educational Dental Clinic offers assistance to Anápolis community (COE) in several areas of dentistry, including endodontic (root canal treatment), prosthetics (dentures, bridges and crowns), dentistry (fillings), periodontics (gum treatment), surgery(extractions), Pediatric Dentistry(children), orthodontics (apparatus), radiology (x-rays), dentistry (oral lesion treatment) and emergencies (toothache).

Treatment is accomplished through a screening in order to determine the patient's needs and the treatment complexity.

Objective:

COE aims to develop a relevant social work through free dental treatments. These free treatments are possible thanks to a partnership with Health Department and SUS (Public Health Care Plan). The less privileged population is screened by the clinic social worker and forwarded to the appropriate dental treatment.

PHARMACY LAB - CLINICAL ANALYSIS

It is a specialized laboratory to assist patients who benefit from the Public Health System (SUS) and also other segments of the population. The exams are conducted by a qualified team of professionals who serves the public and also coach trainees to perform clinical analysis.

To assist community patients in partnership with Public Health System (SUS) in order to perform lab tests.

LEGAL PRACTICE CENTER (NPJ)

Under Law School supervision, Legal Practice Center (NPJ) works as a Law School's office. It has been legally created to meet low-income community. This office provides free attorney services especially focusing on cases involving family issues.

ADVANCED NURSING AMBULATORY (UniCUIDAR)

A clinic created to provide free assistance to internal and external community (low-income community and also Institution students). The clinic activities cover all the components of higher education. They provide the clinical field through teaching, research and extension in the following clinical centers:

- Special monitoring and pedagogical support Center;
- Health Education Center for specific population groups;
- Wound Treatment Center;
- Immunization Center (internal). It also provides support for any contingencies;
- · Occupational accident Assistance Center;
- Support Center for Campaigns and Health Department Programs. It also gives support to the Internal Advisory Committee for Accidents Prevention (CIPA);
- Emergency Health Center (emergency assistance and pre-hospital care), working with SAMU (ambulance service), when indicated

Objective:

To provide basic assistance to the community in general . workers, students and other people.

UniCUIDAR has assisted the low-income community through various procedures such as: blood pressure measurement, immunizations, and health referrals. It has also participated of the H1N1 vaccination campaign in partnership with the Health Department of Anápolis City Hall. UniCUIDAR students also collected material for clinical analysis and performed breast examinations.



JR CONSULTING FIRM

Junior Consulting Firm was founded in 2001 to provide free legal management advice to micro and small enterprises from Anápolis and surroundings. The projects are run by administration students under the supervision of professors with extensive experience in consulting business.

Every year, six junior officers are selected to fill the positions of CEO, Administrative and Financial Director, Project Director, Public Relations Director, Marketing Director and Human Resources Director. Junior Consultant Firm also provides jobs to volunteer Law students interested in the project.

Junior Consultant Firm develops, through the strategic guidance to current and future micro entrepreneurs, an important role in promoting social entrepreneurship and generating innovative ideas.

Actions taken in 2010:

- There were 10 consultancies, including site visits, interviews, meetings, research, data and analysis collection;
- Junior Consultant Firm conducted 30 business guidelines;
- It held 10 market researches;
- Prospecting and dissemination of 111 apprenticeship positions;

UniEVANGÉLICA PHYSICAL EVALUATION LAB (LAFE)

Service Areas

Postural Assessment – it provides an essential overview and awareness of postural deviations (scoliosis) and also angles measurement, by using digital equipment, connected to software (Da Vinci). Thus, it is possible to take pictures and record images of the person's body at various angles.

EMG and goniometer are also used for athlete's physical evaluations.



Anthropometric Assessment – It is an evaluation of body composition, in which

is determined the body fat percentage, lean body mass (muscle), ideal weight, excess weight, water percentage (H2O), height, weight, total body mass, and bone circumference. The procedures require the following instruments: anthropometric tape; adipometer; stadiometer; caliper, fleximeter; scale, and Bioimpedance (Galileo).

Other Procedures: lactic acid Dosage (lactimeter), cholesterol, triglycerides and glucose level. Number of assisted patients: 150

The Academy aims to provide practical reality training to Physical Education students on a daily basis. The student learns the importance of organization and planning to achieve safe and effective results.

The relationship student / gym also occurs through contact services rendered to the community (human performance, supervised muscle recovery, quality of life, physical, social and mental well-being). Currently, the Academy offers to the students, staff and community a total of 33 weight classes and indoor cycling.

It especially targets students who have come from other schools and the ones in need of specific attention. The program lasts the whole school year and it works as an extra curriculum activity. It benefits 200 students during the school year reaching very good results not only academically, but also in the students' self esteem.

Welcome to The 6th Grade

It is a welcoming program that takes place at the end of the 5th grade/2010. This friendly and fun event marks the passage from the Elementary I to Elementary II. It happens every November and it is called WELCOME TO 6th GRADE. In 2010, the students were taken to Estância Parque Hotel where they were greeted by the 6th grade educational staff. It was a day of sightseeing, outdoor activities, dynamics, lunch, photos, pool and much fun for the students and teachers.

Project Re-readings

In contact with the classics of children's literature, students have worked in creative writing. The project put students in contact with the classic literature as Alice in Wonderland and Peter Pan. A reading book has been edited by the House of Young Writers. The end of the project was marked by a book signing night at Richard Senn Main Hall.

Thanksgiving

Thanksgiving (Ações de Graça) Project happened in October and it was a great opportunity for Faculty members and Elementary I and II students to thank God for the school year. The project ended at Richard Senn Main Hall with a worship time.

Field Trips

Field trips are an educational extension of the classroom learning. Students had the opportunity to experience the reality of our state and country through educational oriented trips, enriched by the participation of teachers and guides. PROJECT

Healthy Eating

This project was developed for primary school students in order to encourage the children to know and taste the variety of fruits and vegetables flavors.

Weekly, students learned how to wash the fruits brought from home. They savored the fruits together. The teacher presented the healthy benefits of eating properly, encouraging them to continue this practice at home. Afterwards, the children have drawn the fruits and vegetables they have tasted .

The pedagogical team and the cafeteria staff have planned the weekly menu.

Certainly, the project encouraged children to develop good and healthy habits.

Circus Day

On March 27th, all the primary school students were welcomed to school with different kinds of fun activities. During the whole day, they participated in workshops, they wore clown's make up and they also interpreted circus characters.

Students had the opportunity to watch videos and they had a nice snack.

Respect for Animals

The project promotes closeness between children and animals, creating affection and respect bonds. It also taught the children how to take care of harmless animals.

On September, 2010, teachers told stories and provided direct contact between students and harmless animals such as chicks and bunnies.

Lite' Álvaro

This project was developed during the school year. The students have read literary books and they had to write or explain what they had understood of each story. As a reward for the reading, the students received "money" called Junietes. By the end of August, there was a great party where the students could exchange their "money" for goods and food like: pies, sweets, popcorn, soft drinks, chocolate bars or toys.

The project promoted a reading and writing habit. Every part of this project was designed to lead the student to put learning into practice.

Writing Contest

This project was sponsored by the Council Education Department. The goal was to motivate students to write essays about themes like "Ceres, a synonym for life quality."

Teachers of Portuguese Language developed the project and also chose the best essay. The first place went to the student Neemias Rosa de Melo. He and the Language teacher received a great prize: a Laptop for each one.

Tree Planting

This is a project developed by students, teachers and the principal's staff. The students planted 60 Ipês

tree seedlings (yellow, lilac and pink colors) around the school block. They were also responsible for watering and caring for the trees seedlings everyday. Protection fences were put around each tree. The students could study about this kind of native tree creating an environmental responsibility.

The project is aimed at high school students in order to encourage them to learn about different professions, through discussion (questions and answers) with professionals who were invited to participate in a roundtable discussion.


